

JOB ANNOUNCEMENT
CUSTODIAL/MAINTENANCE WORKER (PART-TIME)

LOCATION: TUBA CITY, AZ

DNA People's Legal Services is a non-profit law firm providing high-quality legal services to people living in poverty in the Navajo, Hopi, and Jicarilla Apache Nations, and parts of Northern Arizona, Northwest New Mexico, and Southern Utah. DNA's main office, as well as DNA's Fort Defiance branch office, are located in Window Rock, Arizona. DNA also has branch offices in Chinle, Arizona, Tuba City, Arizona, Flagstaff, Arizona, on the Hopi BIA judicial compound near Keams Canyon, Arizona, and Farmington, New Mexico. DNA legal staff practice in tribal, state, federal, and administrative courts. DNA is seeking to hire a qualified individual for our open part-time custodial/maintenance worker position located in our Tuba City, Arizona Office.

REQUIREMENTS: Minimum educational requirements are a high school diploma or GED, minimum one year of experience in general maintenance work involving at least one of the skilled trades; or an equivalent combination of training and experience which provides the capability to perform the described duties in building maintenance.

RESPONSIBILITIES INCLUDE:

- (a) Reports to the Facilities Maintenance Manager.
- (b) Performs janitorial duties, daily.
- (c) Work requires extensive lifting, bending, carrying, loading, unloading, transporting equipment and supplies weighing up to 100 lbs.
- (d) Works extended periods of time in an outdoor environment.
- (e) Performs general maintenance and carpentry.
- (f) Performs repairs and/or replaces doors, windows, casing, roofing material, flooring material.
- (g) Perform plumbing activities, installing new plumbing including pipes, drains, tubs, toilets, faucets, sinks, and other plumbing fixtures and equipment.
- (h) Makes repairs on old plumbing; repairs leaks and breaks; replaces washers and valves; clean and open drains and water lines.
- (i) The person must be able to transport, set up, and clean a travel trailer. (Preferred)
- (j) Performs painting activities by preparing surface to be painted including sanding, scraping, patching, priming, and texturing, mixes and applies paints to surfaces; mixes and applies joint compound or plaster;
- (k) Performs some electrical work; replace light bulbs, ballasts, light fixtures, wall plates, outlets, etc.
- (l) Services common household appliances.
- (m) Performs yardwork and landscaping;
- (n) Performs on-call emergency duties for major outages, and sewer backups, etc.
- (o) Provides cross training for coworkers and acquires cross training in other trade areas.
- (p) Provides preventive maintenance, troubleshooting, winterizes and summarizes on heating units and air conditioners.
- (q) Performs preventive maintenance program through scheduled inspection and servicing of equipment, housing, and facilities.
- (r) Maintains a clean and safe work environment.
- (s) Travel to other DNA offices to conduct work may require lodging.
- (t) Performs other related duties as assigned.
